1. That I was a citizen of India when my individual pension account under NPS was opened as per the provisions of the Pension Fund Regulatory and Development Authority (PFRDA) Act, 2013, Rules, Regulations, Circulars, Guidelines Notifications etc., issued by PFRDA.
2. That I have renounced my Indian citizenship w.e.f _____ and do not hold a valid Overseas Citizen of India (OCI) card as on the date of making this application.
3. That I am fully aware that on closure of my NPS account, the entire accumulated pension wealth (Tier I and II) will be transferred to my NRO account, as per the details provided in accordance with the provisions of PFRDA's Circular No. PFRDA/2025/02/REG-EXIT/01 dated 21st April 2025.
4. That my account is a NRO account and the KYC is updated in the said account in compliance with FEMA guidelines issued by RBI from time to time.
5. That I understand that upon closure of my NPS account, neither me nor any of my family member(s), nominee and legal heir etc. shall be entitled to receive any benefit under the NPS.
6. That I further state and confirm that all the details and other information provided by me in the form above are true and correct and that the proceeds will be paid to my NRO account as per the details provided by me.
7. That I agree that PFRDA/NPS Trust / Central Recordkeeping Agency (CRA) shall not be held responsible / liable for any losses or delays that may arise due to any reason including providing incorrect or incomplete details by me in this regard.
8. That I agree that in case of any failure to disclose any information, now or in future, NPS Trust shall be authorised to report to any regulator and/or any authority designated by the Government of India (GoI) /RBI/IRDA/PFRDA for the purpose or initiate any other action as may be deemed appropriate.
9. That I hereby permit / authorise NPS Trust / CRA to collect, store, communicate and process information relating to my NPS Account and all transactions therein, including sharing, transfer and disclosure to the authorities in and/or outside India of any information for compliance with any law or regulation whether domestic or foreign.
10. That I hereby permit / authorise NPS Trust / CRA to verify the authenticity of my bank account (NRO), if required, for settling the accumulated pension wealth directly with the bank or through facilities such as penny drop etc.

12. That I understand that the accuracy, authenticity and veracity of providing the information and data for processing the application / claim by NPS Trust is my responsibility. Based upon the requisite information and data provided by me, the records and the computations available and accessed through the CRA system, claim will be processed by NPS Trust to the best of its knowledge and belief.

13. I/We shall indemnify PFRDA/ NPS Trust, its Trustees and employees for any loss that may arise on account of providing incorrect or incomplete information.
14. I/We undertake that I have paid all the applicable statutory / legal dues in India and hereby indemnify PFRDA / NPS Trust, its Trustees and employees on any statutory / legal claims / provisions arising in my NPS account in the future.
15. I hereby agree that NPS Trust will have no liability or responsibility whatsoever with respect to any errors, omissions, or discrepancies found at any stage. The liability of NPS Trust shall cease upon crediting of the accumulated pension wealth in my NPS account to the NRO account and no further liability shall arise thereafter.

 - a. Self-certified copy of PRAN card. In case copy of PRAN Card is not available, print out of ePRAN duly self-certified may be enclosed.
 - b. Self-certified copy of valid passport of the subscriber issued by the foreign country of which the subscriber is citizen as proof of identity and address.
 - c. Self-certified copy of Bank Passbook or copy of NRO account statement (containing the name of the subscriber, type of account (please note that the account is mandatorily required to be NRO), NRO account number, IFS Code etc.) for direct credit or electronic transfer.
 - d. Self-certified copy of valid Certificate of renunciation of Indian citizenship / surrender certificate / cancelled Indian Passport issued by the competent authority.
 - e. Self-certified copy of PAN card issued by Indian Income Tax Authority.
 - f. Singed FATCA/CRS declaration form.
 - g. Any other document as NPS Trust may deem fit depending upon the circumstances of the application / claim.

Section E – Instructions for filling form

This application / form should be filled by the subscriber seeking to withdraw the entire accumulated pension wealth benefits upon renunciation of Indian citizenship and not holding OCI Card

1. Withdrawal of benefits from NPS account will not be allowed if NPS subscribers registered on or after 01st July, 2014 are NOT FATCA compliant. In case of FATCA non-compliance, the subscriber is requested to provide FATCA Self-Certification, in the format enclosed as Annexure to this form, as on the date immediately prior to the renunciation of his/her Indian citizenship.
2. The subscriber can submit the duly filled and signed form along with all the requisite documents from the registered mail ID in their NPS account either at dept-exit@npstrust.org.in or physically at the office of NPS Trust (please refer the website of NPS Trust for the address <https://www.npstrust.org.in>).
3. All the fields marked with (*) are mandatory and should be filled without any overwriting.
4. Correct contact and address details should be provided.
5. Documents to be enclosed with the withdrawal application form:
 - a. Self-certified copy of PRAN card. If copy of PRAN Card is not available, print out of ePRAN duly self-certified may be enclosed.
 - b. Self-certified copy of valid passport of the subscriber issued by the foreign country of which the subscriber is citizen as proof of identity and address.
 - c. Self-certified copy of Bank Passbook or copy of NRO account statement (containing the name of the subscriber, type of account (please note that the account is mandatorily required to be NRO), NRO account number, IFS Code etc.) for direct credit or electronic transfer.
 - d. Self-certified copy of valid Certificate of renunciation of Indian citizenship / surrender certificate / cancelled Indian Passport issued by the competent authority.
 - e. Self-certified copy of PAN card issued by Indian Income Tax Authority
 - f. Signed FATCA /CRS declaration form.
 - g. Any other document as NPS Trust may deem fit depending upon the circumstances of the application / claim.
