In view of the technical glitch in the system during the conduct of Paper I - English (Descriptive Test) in the said examination, it has been decided by the competent authority to give another opportunity to all the candidates who appeared on 31st July, 2021 to undertake re-test of **Paper I - English (Descriptive Test)** for the post of OFFICER GRADE “B” (MANAGER), scheduled to be held on Saturday, 9th October, 2021.

PHASE II EXAMINATION [RE-TEST OF PAPER I – ENGLISH (DESCRIPTIVE TEST)]

General Instructions

- i) **The re-test is only for Paper I - English (Descriptive Test)** of Phase II exam for the post of OFFICER GRADE “B” (MANAGER).
- ii) The re-test of Paper I - English (Descriptive Test) of Phase II exam for the post of OFFICER GRADE “B” (MANAGER) can be attempted by **only those candidates who appeared for exam held for the said exam on 31st July, 2021**.
- iii) This re-test of Paper I - English (Descriptive Test) of Phase II exam for the post of OFFICER GRADE “B” (MANAGER) will be held on Saturday, 9th October, 2021 at the locations mentioned in Annexure A.
- iv) The candidates who did not appear for Phase II exam for the post of OFFICER GRADE “B” (MANAGER) held on 31st July, 2021, will not be eligible to appear for re-test scheduled to be held on Saturday, 9th October, 2021 and no request or correspondence in this regard will be entertained.
- v) **There is no re-test of Paper II (Objective - Multiple Choice Questions)** of Phase II exam for the post of OFFICER GRADE “B” (MANAGER). The marks scored by candidates in Paper II (Objective - Multiple Choice Questions) for the post of OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 will be considered for evaluation.
- vi) You can choose to appear for re-test Paper I - English (Descriptive Test) of Phase II exam for the post of OFFICER GRADE “B” (MANAGER) scheduled to be held on Saturday, 9th October, 2021 at your discretion.
- vii) If you choose to appear for re-test of Paper I - English (Descriptive Test), **the marks obtained by you in the re-test of Paper I - English (Descriptive Test) of Phase II exam scheduled to be held on Saturday, 9th October, 2021, will only be considered for evaluation**. The marks obtained in the Paper I - English (Descriptive Test) of Phase II exam for the post of OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 will not be considered and no request or correspondence in this regard will be entertained.
- viii) The candidates have to make their own arrangement for lodging /travelling/conveyance etc. for appearing in the re-test and NPS Trust owes no responsibility or liability towards arrangement of any such facility or allowance or reimbursement of any expenses incurred in this regard.
- ix) If you choose not to appear in the re-test scheduled to be held on Saturday, 9th October, 2021, and select the option “No” for the question “*Would you like to appear for the Re-test for Paper I (Descriptive Paper)*”, call letters will NOT be generated for such candidates. In that case, the marks obtained by you in Paper I - English (Descriptive Test) of Phase II exam for the post of OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 will be considered for evaluation and no request or correspondence in this regard will be entertained.

- x) In case the candidate does not visit the link by 27th September 2021, and does not choose any option, the centre where the candidate appeared for Phase II exam for OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 will be allotted by default and no request for change of date/venue/shift/timing etc. will be entertained.
- xi) The aggregation of marks of candidates who have appeared for exam for OFFICER GRADE “B” (MANAGER) held on 31st July 2021 and who do not appear for re-test will be as per Annexure B.
- xii) The aggregation of marks of candidates who have appeared for exam for OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 and who will appear for re-test will be as per Annexure C.
- xiii) Candidates can choose the centre for examination (city) from the link available on NPS Trust’s website www.npstrust.org.in for their exam centre choice. After the candidate has chosen the centre for examination, no request for change of date/venue/shift/timing etc. will be entertained. Notwithstanding the aforesaid provision, NPS Trust reserves the right to change the date/centres/venue/shift/timing at its discretion. In case the candidate does not choose any centre from the link given by 27th September 2021, the centre where the candidate appeared for Phase II exam for OFFICER GRADE “B” (MANAGER) held on 31st July, 2021 will be allotted by default and no request for change of date/venue/shift/timing etc. will be entertained.
- xiv) All the Corrigendum/Addendum/Notices, if any, issued with respect to for the post of OFFICER GRADE ‘B’ (MANAGER), will be published only on NPS Trust’s website www.npstrust.org.in.
- xv) All the other terms, conditions and instructions issued vide recruitment notification no 2/2021 dated 24th December, 2020 for the post of OFFICER GRADE ‘B’ (MANAGER), shall remain unchanged.
- xvi) In all matters regarding eligibility, conduct of examinations, group discussions, interviews, assessment, prescribing minimum qualifying standards in both the Examination, Group Discussion and Interview, in relation to number of vacancies and communication of result, NPS Trust’s decision shall be final and binding on the candidates and no correspondence shall be entertained in this regard. Further, NPS Trust reserves the right to relax any of the requirements for the candidates in deserving cases. NPS Trust also reserves the right to cancel/modify the advertisement, fully or partly on any grounds.
- xvii) Any dispute arising out of the advertisement including Corrigendum/Addendum/Notices for the post of OFFICER GRADE ‘B’ (MANAGER), shall be subject to the exclusive jurisdiction of the Courts situated at New Delhi only.
